After the recognition, PJ Shelton led the Commission into a brief session thanking Commissioners and Staff for their work and accomplishments in making a difference in the lives of young children in Contra Costa County.

Dr. Rocio Hernandez arrived at this time.

6.0 Presentation of the 2019 Year in Review

Sean Casey presented the year in review with the following highlights:

Over 9,007 children, 11,757 parents & caregivers and 1,529 providers (unduplicated numbers) were directly served in First 5's principal funded initiatives.

One of the major achievements of the year was the opening of the East County First 5 Center in Pittsburg. Overall, nearly 2000 children and another 2000 caregivers participated in activities across the five First 5 Centers sites this year. Welcome Home Baby recorded nearly 8,000 home visits and 41 socializations.

Help Me Grow continued to build its impact in the community, with over 2,700 developmental screenings reported among participating providers. The 2-1-1 system reported a 67% increase in the number of families compared to fiscal year 2017/18. While 212 children participated in a Help Me Grow developmental playgroup, another 438 received targeted intervention services to help them stay in their childcare program.

This year, the Quality Matters program reached a record 184 sites including 48 new sites recruited for the high quality early education program. The program reached 542 teachers in professional development and training, representing as many as 6,400 children served – including infants, toddlers, and pre-k. With the participation of Tandem at every QM site, 4,000 children and their families participated in the book bag sharing program.

This year marked another major accomplishment with the first-ever Contra Costa Community Forum on Early Childhood Mental Health, a collaboration among First 5, the Early Childhood Prevention and Intervention Coalition and the County Behavioral Health Division. Over 115 community participants gathered to discuss the social and emotional needs of young children and how they could be addressed in the County's Mental Health Services Act three-year plan.

Our advocacy efforts continued this year with Commissioner Marilyn Lucey joining staff in Sacramento for the statewide First 5 advocacy day. Our second Annual Coffee & Kids Policy Breakfast over 100 attendees heard Under-Secretary of Health and Human Services for Early Childhood Kris Perry describe the groundbreaking state budget for early childhood and for families.

The Family Economic Security Partnership brought together over 45 agencies together through its events, with over 150 staff and constituents educated on topics important to families (shelter, tax filing assistance, importance of voting, census, etc.).



Our Community Engagement program involved 700 families in twelve advocacy activities for affordable and secure housing for children and families. Additionally the Regional Groups continued their ongoing work to improve parks for families, most notably in Richmond, Concord and Bay Point. To date resident advocacy has secured over \$3 million in local funding for park improvements. .

Congressman Mark DeSaulnier visited the East County First 5 Center to speak to his attempts to significantly increase funding for IDEA "Part C" activities that support critical intervention for children with special needs. A former First 5 Commissioner, Congressman DeSaulnier sat down with children in a developmental playgroup session and spoke with parents about their challenges and concerns for their children with special needs.

Additionally 621 professionals attended trainings in trauma, early childhood education and community/civic engagement

Looking ahead, 2020 will be busy. January will see the release of the Governor's budget proposal for the year, the launch of First 5's newly re-designed website including the new Contra Costa Childcare Dashboard, and "Positive Parenting Month." There will be park improvements in Ambrose Community Park in Bay Point and Boorman Park in Richmond, the 3rd annual Coffee and Kids breakfast, and the expansion of the Ready Kids initiative.

7.0 Annual Report to First 5 California for Fiscal Year 2018 – 2019.

The commission is statutorily required to have a public hearing on its annual report to the state.

Chairman Gareth Ashley opened the public hearing at 6:54 PM on the annual report to California First 5 For the fiscal year 2018-19. He informed the Commission that the collected data from all First 5s is used by the First 5 Association to educate funders, advocates and legislators about the statewide impact of First 5.

Sean reported that the findings and data support the year-end report above. The format of the summary is prescribed by the state.

There were no comments from the public, and the chair closed the public hearing at 6:56 PM.

related to First 5 Centers (\$841,227); and eliminating the \$7.5 million "contingency fund" created by the Commission in 2011.

Sean reported on the Strategic Plan for FY 2020/21 to 2022/23.

The plan itself is in the format the Commission saw at its October retreat. Revisions made since that meeting, in response to your thoughtful recommendations and suggestions are in purple typeface in the final draft.

The Strategic Plan also includes the fiscal plan for the next three years. As we discussed in October, we believe that up to \$9 million in the Commission's remaining unassigned fund balance could be made available over the three years to sustain current activities. To do so, the plan requires that the Commission release funds remaining in the capital spending account for First 5 Centers and eliminate the "contingency fund" consisting of \$7.5 million held back for exceptional circumstances. At the time the fund was created in 2011, the Commission had very real concern that the state would attempt to claw back county First 5's fund balances to addressing the ongoing state budget deficit. Today that threat is no longer an issue and we feel confident that only a modest fund balance is necessary.

Dr. Farnitano made the motion, seconded by PJ Shelton, to adopt the First 5 Contra Costa Strategic Plan for fiscal years 2020/21 to 2022/23; releasing the remaining fund balance committed by the Commission 2004 for capital spending related to First 5 Centers (\$841,227); and eliminating the \$7.5 million "contingency fund" created by the Commission in 2011.

After the vote, Sean Casey thanked outgoing officer Gareth Ashley for being Chair of the Commission for the last two calendar years, and presented him with a desk clock on behalf of First 5 Contra Costa.

10.0 Ad Hoc Committee update on the search for an executive director

Sub-committee chair PJ Shelton reported that the Ad Hoc Committee on the executive director search have completed the interview process.

The consultant posted the search early October 2019 including a brochure of First 5 Contra Costa designed specifically for the search. We received 37 applicants. The consultants narrowed the selection and telephone interviewed 12 candidates with potential qualifications.

The Ad Hoc Committee selected 6 finalists and had the consultants invite them to an interview with the sub-committee last December 10th and 11th. Five of the applicants were successfully interviewed (1 missed their scheduled appointment).

The sub-committee deliberated and selected the 2 most qualified candidates. These 2 candidates will be coming in on an interview with the Commissioners in a closed session on December 16, 2019.

PJ thanked everyone on the panel.

Deputy County Counsel Keiko Kobayashi reminded that the interview will be in a closed session and attended only by primary Commissioners. Alternates may attend if the primary Commissioner is unable to attend.

The official announcement of the new First 5 Contra Costa executive director will be made at the January 13, 2020 Commission meeting.

Diane Burgis left the meeting at this time.

11.0 Executive Director's Report

Sean Casey gave the following report:

Revenues

I want to let you know that our state association and First 5 California are closely monitoring the Proposition 10 revenues reported by the California Department of Taxation and Fee Administration, or CDTFA. Earlier this year CDTFA had problems with its new accounting system and was unable to report the last two months of the last fiscal year until September. Recently they posted the July revenue and estimates for August and September, which were 37%, 3%, and 77% below the previous year's respective months. We do not know if this is a result of administrative fees or other expenses. And we don't yet know what the Prop 56 backfill from the previous year will be.

On the more hopeful side of the revenue question, I want you to know that staff are fully engaged in the stakeholder process behind a potential county sales tax measure for next fall. The BOS has invited a number of representatives of services agencies and labor to form an ad hoc workgroup to come up with recommendations as to how a one-cent sales tax yielding over \$90 million a year could be applied. The



BOS is anticipating it will be a general tax, requiring only a majority of voters to support, which means no specific use can be spelled out on the ballot. The Board might support an advisory measure that could lay out potential uses generally if the tax passed. First 5 will continue to be involved in these early discussions.

Transitions

Moira Kenney, who has been the very able leader of the First 5 Association for the past 8 years, announced last month that she would be leaving her post in January for personal reasons. She has been instrumental in building the Association's visibility in Sacramento and across the state, hiring a full-time policy director, driving the creation of the First 5 Network, and drawing in funding from several major foundations. A search will soon be underway for her replacement; former First 5 Stanislaus County Exec Dir John Sims will serve as interim ED until a permanent Ed is established. The Executive Committee for the Association is also very closely involved in the transition.

We have had two staff transitions here as well. Lauren Wagner, our former Research Analyst, is now at the San Francisco Children's Council, the child care resource and referral agency for San Francisco, similar to our own CoCoKids. And Linda Frazier-Stafford, one of our Quality Matters coaches, will soon be supervising the West County Head Start sites for our own Community Services Bureau. They will both be missed, and we wish them well.

Upcoming items:

I sent an inquiry to the Commission earlier about your possible participation in the Leadership for Equity and Opportunity, or LEO, program that begins in February. This is a three-part intensive cohort training on principles of problem solving and leadership that are grounded in universal values like equity, dignity and compassion. We feel that the process imagined in LEO will be closely aligned to the systems change model in our strategic plan. We expect to have as many as 13 staff participate, and perhaps one Commission, Marilyn Lucey. If you think you might be interested please let us know; Ruth is preparing the applications. This could be a deeply meaningful shared experience for First 5 in the coming year.

Also coming up: the census! First 5 is part of a 0-5 working group, with Healthy and Active Before 5, CoCoKids, Head Start, the COE and Health Services to carry out outreach in the weeks leading up to the census April 1, particularly to families with infants and toddler. Staff will provide a presentation at one of the upcoming meetings.

Lastly, expect to see a contract in the early part of the year for a property manager to support the First 5 Center sites, both those we own and those we lease. This will be of great benefit as we address the needs of heavily used buildings and keep them in good repair. Staff expect to put out an RFP for this in the coming weeks.

Background:

The First 5 Commission selected Ruth Fernandez to serve in the position of Executive Director effective January 13, 2020, subject to the terms and conditions of an employment agreement. Negotiation have been successfully concluded and the Commission is asked to approve the attached agreement and authorize its execution.

Recommendation:

APPROVE and AUTHORIZE the Chair, First 5 Contra Costa, to execute an employment agreement with Ruth Fernandez to serve as Executive Director of First 5 Contra Costa commencing January 13, 2020.

Dear Ruth Fernández:

It gives me pleasure to confirm our offer of the Executive Director position with First 5 Contra Costa Children and Families Commission. The salary and benefits described below will be effective on your start date January 13, 2020. As Executive Director, you will serve at the pleasure of the First 5 Contra Costa Children and Families Commission.

Salary. On an annualized basis, your base compensation will be \$160,825.00. This salary will be reviewed at the end of 12 months, no later than January 31, 2021. Based on your performance you may receive a pay adjustment at that time. Salary increases range from 0% to 5%.

Additionally, you are eligible to receive a Cost of Living Adjustment (COLA) when approved by the Commission. If awarded, the COLA is generally applied at the beginning of a fiscal year (July 1).

Performance Expectations. The First 5 Contra Costa Executive Committee will work with you to establish specific performance expectations concerning your performance as Executive Director. These performance expectations will be reviewed in Executive Committee meetings on a quarterly basis, and used to evaluate your performance at the end of 12 months, no later than January 31, 2021.

Benefits and Leaves. Attached is an overview of benefits and leaves offered by First 5 Contra Costa for your position. More information can be found in the Employee Compensation and Benefits Resolution 2019/001.

In accordance with our policy, your employment is <u>at will</u>, which means that either First 5 or you may terminate your employment at any time, for any reason, with or without cause or notice. By signing below, you represent that you are free to accept the terms of this offer and that your acceptance and performance shall not constitute a breach of any other obligations to any other party.

Benefits and Leaves Overview

Standard Benefits. You will continue to receive the standard benefits that are offered to all First 5 Contra Costa employees as set forth in the Employee Compensation and Benefits Resolution 2019/001.

- 1. Medical: 8 health plans through four carriers for employees and qualifying dependents. First 5 Contra Costa pays 80% of premiums.
- 2. Dental: 2 dental plans for employees and qualifying dependents. First 5 pays the same rate as the County unrepresented employees.
- 3. Vision: A voluntary vision plan for employees and qualifying dependents. 100% employee paid.
- 4. Employee Assistance Programs: 2 EAP programs
- 5. Flexible Spending Accounts: Dependent Care Assistance Program and Health Care Spending Account.
- 6. Paid Leave
 - a) Vacation: 10 hours accrued per month.
 - b) Personal Holiday: 2 hours accrued per month.
 - c) Sick Leave: 8 hours accrued per month.
- 7. Holidays: 10 observed holidays each calendar year.
- 8. Retirement: Contra Costa County Employee's Retirement Association (CCCERA). A defined benefit retirement plan that provides a fixed, pre-established benefit for employees at retirement. Participation is automatic and cannot be waived.
- 9. Deferred Compensation Plan (457): A voluntary plan; after qualifying base amount reached, First 5 matches \$85 monthly.
- 10. Short- and Long-Term Disability
 - a) STD: 100% employer paid. Up to \$1,500 per week.
 - b) LTD: 85% of total monthly earnings.
