## 1. Community Engagement

## Census 2020: Canvassing Trainings and Upcoming Events

The CE canvassing effort is providing peer-to-peer outreach to families most likely to be uncounted or undercounted in the census. In the month of January, the CE Program held 3 canvassing trainings and built leadership capacity in over 75 Regional Group members. In an effort to reach underrepresented families with young children in Concord, Richmond, San Pablo, Bay Point and Antioch, the Regional Groups have already canvassed 300 homes/apartments and spoken with over 100 families in a single month. This strong effort will continue until the end of April and possibly beyond.

In order to further census outreach, and strengthen community partnerships, the CCRG and ECRG will host Community Census Events at local parks in the spring:

- March 14 (East County) Anuta Park, Bay Point
- March 28 (Central County) Ellis Lake Park, Concord



## **Concord Housing Campaign Continues**

On February 11, 2020, the Concord City Council will discuss implementation of statewide tenant protections secured through AB1482. The CCRG will attend and continue to voice the need for stronger local tenant protections and to emphasize the need for policy intervention to alleviate the housing crisis on Concord that directly affects our young children and families.

## 2. Early Intervention

## January is Proclaimed Positive Parenting Awareness **Month**

The Early Intervention Initiative was part of a local coalition that advocated for the successful proclamation of January as Positive Parenting Month—both at the county level with the Board of Supervisors and within the state Assembly (the state proclamation is currently moving through the senate for approval).

As part of this effort, our Early Intervention Program Officer met with several state legislators (Senator Nancy Skinner and Assembly members Rob Bonta and Steve Glazer) and shared the work that First 5 Contra Costa is doing to support families and children in our local community.



## MHSA Funding for Prenatal to 5 Services

First 5 is leading the effort to obtain additional MHSA dollars focused on the 0-5 population. Our Early Childhood Prevention and Intervention Coalition (ECPIC) met with MHSA staff (Warren Hayes and Jennifer Bruggeman) to discuss next steps for assisting them in elevating the needs of young children within the MHSA structure. ECPIC provided a white paper to MHSA to underscore the need for access to funding to build an early childhood mental health system of care.



## 3. Early Childhood Education

## **Quality Matters and QRIS Updates**

Interviews for the new Quality Improvement Coaching Coordinator began the week of January 21. This position will provide coaching, technical assistance and training to providers in identified early care and education programs to improve the quality of early learning programs participating in Contra Costa Quality Rating and Improvement System (QRIS). Rating season has begun for Quality Matters programs in cohorts 1, 3, 5 and 7 – QRIS ratings take place every two years under the current structure.

## Contra Costa Professional Development Program (PDP) 2019-20 Application Period

We are happy to report that the application period for the PDP ended January 15, 2020. PDP primary goal is to incentive ECE workforce development through degree attainment.

A total of 204 applications were approved for the 2019-20 FY - 112 applications of the 204 approvals are teachers at private centers and family child care providers, and 92 applications are from State-Funded teaching staff.

The anticipated allocation for stipends is \$134,213, with \$70,400 being from First 5 funds and \$63,813 from AB212 funds. AB 212 funds supports State-Funded programs, whereas First 5 funds support Private Centers, Family Child Care Homes, and Head Start sites. Approved applications included several stipend categories based on college coursework completion, specific educational milestones, such as teacher permit upgrade, Associate of Arts and Bachelor's degrees' completion, lost wages support while teachers complete the required Practicum course, foreign transcripts evaluations, and professional development activities (trainings). Stipends range from \$300-\$1,300. Out of the 204 teachers approved for a stipend, 150 were approved for the coursework stipend.

## Supporting Kindergarten Readiness

On January 23, First 5 hosted a group debrief meeting as follow-up to the Policy, Practice and Partnership Conference held in San Mateo on November 20, 2019. A delegation of 15 Contra Costa stakeholders attended the conference and were invited to participate in the debrief meeting to share common themes and takeaways, as well as to discuss how to strengthen partnerships and leverage the recently released case studies report titled: Supporting Kindergarten Readiness: District-Operated Preschool Programs in Contra Cosa County. First 5 will continue to convene community discussions to explore opportunities to increase Kindergarten Readiness in East County as part of the Ready Kids East County initiative funded by the Lesher Foundation.

## 4. Family Support

## Lisa Korb Acknowledged for her role in a Leadership Team

First 5 Family Support Program Officer, Lisa Korb was acknowledged for her role in a select leadership group that worked for a year to define the terms of a merger between California Family Resource Association (CFRA) and the California Network of Family Strengthening Networks (CNFSN). Both the entities brought together a team of experts and leaders across the state to ensure a smooth transition in the merger, and to increase connection and communication across the Family Support field.



East County First 5 Center Attends "Vehicles for Change" Training



The East County First 5 Center staff team, along with First 5 Family Support Program Officer, attended the Vehicles for Change two-day training in Sacramento and received tools to help with their engagement and outreach efforts to Pittsburg residents. Vehicles for Change is a monograph written and published in 2017 to capture the emerging field of Family Resource Centers (FRCs) in California. In order to respond to the growing body of research and best practices while remaining anchored in the deep and rich history invested in the well-being of children, families, and communities, Vehicles for Change was included in the development of FRCs.

Lisa Korb also completed a three-day Trainer of Trainers seminar that qualifies her to teach the curriculum that brings the monograph to life. She is currently the only non-Strategies 2.0 trainer in the state—Strategies is the statewide technical assistance organization funded by Office of Child Abuse and Prevention.

## 5. Family Economic Security Partnership (FESP)

## FESP Meeting: Census, Voter, and Earn it, Keep it, Save it! (EKS) Outreach

At the FESP meeting on January 22, a new interactive census map that details where census-related activities are occurring throughout the county was shared, along with a short discussion on "Your Vote Matters" with tips for registering, checking voter registration, and learning more about the ballot with a list of Contra Costa candidates up for election on the March primary.



FESP members also learned where the Volunteer Income Tax Assistance sites will be located for free tax preparation to help families claim the Earned Income Tax Credit, and heard from three agencies about how they are integrating information-sharing and outreach for all three important events. Information was also shared on the new state budget and what to watch for related to economic security.

## Grantee Convening on Equity Strategy

First 5 staff attended a San Francisco Foundation grantee convening (January 14) at which feedback was provided on their strategic priorities for their equity strategy and plans to further support predominately communities of color to become more economically secure, vibrant, and civically engaged—Fran Biderman, First 5 Special Projects Coordinator was part of the Planning Committee for this event.

#### Tax-revenue Measure

Fran Biderman attended a third meeting of the Sales Tax Revenue Ad Hoc committee, which is hoping to place a ½ cent sales tax on the November 2020 ballot which would bring in \$93 million to the county. The Working Group structure was revamped and currently there is the Ad Hoc Committee and a Political Strategy committee, which will develop a timeline and oversee the first part of the effort. A consultant is being hired and funding is being sought to cover initial expenses and polling to ascertain interest in a sales tax—First 5 will be contributing to the effort.

## Plans are Gearing up for Census Outreach

First 5 Contra Costa continues to be represented at the Census 2020 Steering Committee (January 27), the joint Outreach and Finance Committee meeting (January 21), and the Census Coalition meeting which consisted primarily of organizations doing canvassing and door knocking in partnership with community residents.





A mini-grant proposal was submitted to the First 5 Association for funds to cover printing costs and swag (tote bags, First Aid Kits, Lip Balm, coloring books) that can be used during outreach efforts and at events to encourage families with young children to participate in the census. F5CC also developed a postcard in English and Spanish encouraging folks to do the census while also emphasizing confidentiality and the fact that there is no citizen question on the census.

## FESP Partnerships

FESP continues to participate on numerous coalitions that are trying to change systems and enhance policies to improve the lives of those struggling to make ends meet, including the Budget Justice Coalition (BJC), the Cal Fresh Working Group, Ensuring Opportunity, Rise Together, and Mobility LABs. Of particular note, the BJC is working with Contra Costa County Departments and the Bay Area Equity Atlas/PolicyLink to present data on community needs at the Board of Supervisors' annual Economic Summit (March 24) to demonstrate that despite a rosy economy, not everyone is benefitting—First 5 Contra Costa is represented in the Steering Committee member of BJC.

Executive Director's Report: The Governor's 2020-21 Budget Proposal



## The First 5 Association FY 2020-21 State Budget: Overview & Early Analysis

Updated: January 10, 2020

Governor Newsom announced his 2020-21 State Budget today. Emphasizing many of the themes of his inaugural budget, the Governor introduced a \$222 billion state budget that expanded services to tackle homelessness and address affordability across CA.

Again, Early Childhood had its own section of the budget, signaling the importance and focus on children's issues and on advancing the Governor's "Parents Agenda". The Governor continues to use his framework from last year to expand children's service through the lens of:

- 1) Expanding early access for children to educational and health care services, including those with ACEs;
- 2) Promoting two-generational approaches that invest in parents so they can invest more in their children; and
- 3) Easing the financial pressures that parents face daily so they can escape the cycle of poverty.

A key proposal in the Governor's budget was the creation of the **Department of Early Childhood Development** under the CA Health and Human Services Agency (CHHS), effective July 1, 2021. The goal of this department is to promote a unified, quality, and affordable child under a single system of state administration and to reduce agency silos – *see listed program purview below*. The CA Department of Education (CDE) will continue to administer the California State Preschool Program (CSPP) and the State Board of Education, and will work in concert with the Department of Early Childhood Development.

#### Department of Early Childhood Development:

- Early Childhood Policy Council
- CalWORKs child care (all stages)
- Voucher-based programs
- Direct contract programs
- Head Start and Early Head Start
- Emergency child care bridge program (for foster children)
- Child care quality programs

The budget includes **\$8.5** million from the General Fund to establish a transition team at CHHS and will support staffing to carry out the child care collective bargaining activities (AB 378, Limon).

## I. Quality Early Learning

#### **Master Plan for Early Learning and Care (MPELC)**

The Governor emphasized his 2019 investments and intended direction through the MPELC, citing the charge to develop a long-term strategic plan to provide a roadmap towards universal preschool and a comprehensive, quality, and affordable child care system. Final recommendations are due October 1, 2020.

#### **Expanded Access:**

Building on investments in the 2019 budget, the Governor proposes to expand child care access through the following efforts:

- \$53.8 million increase in General Fund to CalWORKs Stage 2 and Stage 3
- \$50 million in ongoing funding from the Cannabis Fund (Prop 64) to support over 3,000 General Child Care slots, and an additional \$10.3 million for 621 General Child Care slots. This budget also continues to dedicate \$80 million from the Cannabis Fund towards the Alternative Payment Program. In total, this Budget dedicates \$140 million from Cannabis Funding towards increased child care access.
- \$31.9 million in 2020-21 and \$127 million ongoing non-Prop 98 funds to support an additional 10,000 CSPP slots at non-local educational agencies, beginning April 1, 2021.

#### **Facilities:**

The Governor proposes threes ways to expand early learning and care facilities:

- Allowing more flexibility for the \$300 million that remains from last year's budget to expand full-day kindergarten. The Budget proposes dedicating a portion of these funds to support the construction of preschool facilities on school campuses, although actual dollar figures have not yet been released.
- Adding \$75 million of Prop 98 to expand the Inclusive Early Education Expansion Program, which
  provides funding to local educational agencies to construct or modify preschool facilities to serve
  student with exceptional needs.
- If the \$15 billion Public Preschool, K-12, and College Health and Safety Bond Act passes on March 3rd, the Administration will propose a statute to create a per-pupil grant enhancement for local education agencies that aim to expand preschool programs on school campuses.

## **II. Family Resiliency**

#### **Paid Family Leave:**

The Administration has vocally set its goal of expanding Paid Family Leave to six months for two parents to bond with a new child. The 2019 Budget Act expanded the Paid Family Leave benefit duration from six to eight weeks. This year's Budget builds on this expansion by proposing to provide universal job protection to all employees who pay into the PFL fund. This means that small business owners, regardless of the number of employees, must offer job-protected leave. This move will also enable more employees who pay into the fund to access it.

## III. Comprehensive Health & Development

#### **Behavioral Health**

The Budget makes strides in enhancing and integrating behavioral health supports with physical wellbeing. These initiatives, many of which are currently underway, include:

Establishment of a Behavioral Health Taskforce at the Health and Human Services Agency, which
will bring together relevant departments, consumers, counties, health plans, providers and other
stakeholder to identify ways to improve the quality of care and system coordination.

- Renaming the CalAIM initiative the Healthier CA for All Initiative, which aims to improve Medi-Cal services, including behavioral health benefits.
- Reforming the Mental Health Services Act (Prop 63). Highlighting the \$500 million in unspent
  county reserves, the Governor intends to introduce a proposal later this spring to focus the Act
  on: 1) people with mental illness who are also experiencing homelessness; 2) people involved in
  the criminal justice system; and 3) early intervention for youth.

## Office of the Surgeon General:

**\$10** million in one-time funding to develop a cross-sector training program for ACES, and for a public awareness program, around trauma-informed and trauma-sensitive responses, for specific sectors including early childhood, education, government and law enforcement. This will build upon the ACEs Aware Campaign that recently launched.

#### A Focus on Implementation of 2019-20 Budget:

The 2019 State Budget substantially increased funding for home visiting, developmental screening, and Black Infant Health (BIH). While no additional investments were proposed, this budget maintains the commitment to implementing those programs and focusing on integrating early childhood health and wellness in the state's broader Medi-Cal reform efforts.

## IV. Sustainability & Scale

## **New Vaping Tax:**

To address increased youth vaping habits, the budget proposes a new nicotine content-based e-cigarette tax. The new vaping tax is scheduled to take effect on January 1, 2021, and will be \$2 for each 40 milligrams of nicotine in the product. Best estimates indicate that this could generate around \$32 million in funding annually, which will be deposited into a new special fund to be used for administration, enforcement, youth prevention, and health care workforce programs. Lastly, it is worth noting that the Governor will push to ban flavored vaping products, an effort that is also currently being championed by Senator Jerry Hill through SB 793.

## **Prop 10:**

The budget includes projections for cigarette tax revenues and tobacco consumption. These projections are based on projected per capita consumption of cigarettes, population growth, and the impact from the higher smoking age as well as the increased prices due to Proposition 56. Revenue estimates for other tobacco products, which now include electronic cigarettes, also reflect recent law changes.

Total tax-paid packs of cigarettes sold in 2018-19 were 624 million. In 2020-21, tax-paid packs of cigarettes sold are forecast to decline to 585 million. The chart below provides the projected revenues for all existing tobacco taxes, including Prop 10.
