1.0 Call to Order and Roll Call

4.0 Consider for discussion any items removed from the consent calendar.

5.0 Receive presentation of First 5 Association of California's Executive Director Melissa Stafford Jones on First 5 Association's state-level efforts.

Ruth Fernández introduced guest speaker, First 5 Association of California's Executive Director Melissa Stafford Jones.

Melissa provided a slide presentation (included in the packet) outlining the First 5 Association's 2021 State and Federal Policy Developments for Young Children and Families, an overview of the First 5 Association's 2022-24 Strategic Plan, Race, Ethnicity, Diversity and Inclusion (REDI) Activities and other Learning and Engagement Opportunities.

Melissa shared that there will be a more detailed written version of the 2022-24 Strategic Plan during the official rollout in October.



State policy highlights included mention of several early childhood areas addressed in the 2021-2022 State Budget in the areas of a) Family Supports (Paid Family Leave and Universal Based Income Pilot (UBI)), b) Health and Development (new approved benefits postpartum, access to doula care, and additional funds for Regional Centers and IDEA early intervention services), and c) Early Care and Learning (including rate reforms, additional slots for providers which includes Family, Friends and Neighbors with a focus on equity).

Additionally, Melissa underscored the REDI as a core principle for the First 5 Association's work and intentionality in centering equity for individual leaders at the organizational level in local First 5 County Commission, and for the Association's own policy work.

At the end of three years, the goal is to see a different level of capacity and shift in how the First 5 Association will conduct work that centers on families.

Melissa responded to questions and made the following additional comments:

First 5's whole child, whole family framework is strongly aligned in the work of the Governor's Early Childhood Policy Committee and the Master Plan. The proposals and the positions that the Association takes on are based on deeply informed local experience and from the expertise of the local First 5s.

In response to questions regarding ACES: Some First 5s and local coalitions had applied for and received some grants to increase ACEs awareness, specifically related to Health Providers of ACEs screenings. There are growing themes developing in State Policy and across community based health care systems for networks of care and the effort to make closed loop connections and referrals. Local First 5s with their local partners are grounded in that and there is enormous potential to coordinate and integrate and partner with the Medical System in some new and innovative ways.

Ruth Fernández thanked Melissa for the presentation and the First 5 Association's continued support of its local First 5.

6.0 Consider appointing the Nominating Committee for 2022 Officers' Election

Ruth Fernández presented the 2022 Nominating Committee process and timeline.

She shared that the Nominating committee shall be comprised of 3-5 Commissioners, and that **any** Commission member may serve. She explained the minimal commitment level needed including a meeting leading up to the announcement of nominees for Officers' Election 2022.

The committee will be selected for the sole purpose of selecting a single slate of nominees for Officers' Election 2022 to be presented for vote by the membership at the December meeting of the Commission.

Gareth Ashley, Dr. Chris Farnitano and John Jones volunteered to serve.

Motion was made by Roslyn Gentry seconded by Lee Ross, to appoint Gareth Ashley, Chris Farnitano and John Jones to serve on the Nominating Committee for 2022 Officers' Election.

Due to increase in his work load, he spoke with District 4 Alternate Matt Regan and suggested they switch roles. Both agreed and requested the District 4 Board Office to re-assign them during their re-appointment period.

John Jones and Lee Ross expressed sadness for Shawn Garcia's announcement of leaving First 5 Contra Costa. They wished her best, and thanked her for her many years of service.
